LEARNER'S HEALTH & SAFETY POLICY

1. INTRODUCTION.

- **1.1** MRG Services UK Ltd embraces the Safe Learner Blueprint and will ensure that all learners are in a 'Safe, Healthy and Supportive Environment.
- 1.2 The Safe Learner blueprint sets out the health and safety information that should be covered by training providers and employers of individuals in work-based learning. The intention of the Safe Learner blueprint is to influence learners' safety behaviours in work as well as in the learning situation, by increasing their health and safety knowledge and awareness of the actions they should take.
- 1.3 This is reflected with the Company 'Health & Safety Policy' Part IV, the whole policy will be explained during the induction period for all programmes.
- 1.4 This document is to outline the main requirements and information to help all learners in safe, health and welfare issues or details on safeguarding of vulnerable learners, harassment and bullying.
- 1.5 In accordance with the Health and Safety at Work Act etc 1974 and all other relevant Statutes, Regulations and Orders including MRG Services UK Ltd acknowledges its responsibility to provide and maintain, so far as it is reasonably practicable, that all Learners participating in training programmes run by MRG Services UK Ltd, are working in an environment that provides a healthy, safe and supportive environment as per the 'Safe Learner Blueprint'.

2. ASSESSORS/TUTOR/HEALTH & SAFETY OFFICER.

2.1 Every learner will have a dedicated assessor, tutor whom they can discuss any concerns they have during the programme or any health and safety or safeguarding issues. A member of the health & safety will conduct frequent monitors with the employers. All learners can contact the Company health and safety office on (0151) 944 1744.

3. LEARNER OWN SAFETY

3.1. Every learner must have a supervisor and be able to communicate workplace safety issues. Learners MUST not conduct any work that they have not been trained in or any work that you feel may hurt you or any other work colleagues.

4. BEHAVIOUR

4.1 Behaviour must at times be at a high standard, poor behaviour can be the starting point of a serious incident or accident.

5. ACCIDENTS

6. REPORTING ACTS OF HARASSMENT OR BULLYING

- 6.5 Discuss it with your Personal Tutor, assessor or another member of staff of MRG Services UK Ltd. They will be able to assist you to find the help you need and will welcome the opportunity to help you to improve the way you and others behave towards each other in the Company or workplace.
